Contract Terms and Guidelines:

These courses are being offered to assist your student in recovering credit or D clean-up for graduation or college eligibility. Your student is invited to participate in this credit recovery program through Ann Sobrato High School.

By signing this agreement, student and parent/guardian agree and fully understand the following:

- These are independent courses. In order to be successful while taking these courses, students are expected to have the skills necessary for independent learning.
- Student is expected to work at school, at home, as well as use any other independent study location to complete each course in a timely manner.
- A certificated teacher will be present during on site course times (see reverse).
- All tests are taken on site at **Ann Sobrato High School** with an assigned certificated teacher.
- Credit recovery courses will be assigned on a first come, first served basis. Space is limited.
- Student must complete all work before the end date listed on the reverse side of this contract.
- Student must attend on site classes as designated; 1.5 hours per day, twice a week, within the dates listed on the reverse side of this contract as noted.
- Student must behave in a mature and appropriate manner when attending this class.
- Student must be respectful of others and of school property.
- Student agrees to complete the course before the end date listed on this contract.
- Regular attendance is expected.
- Notebooks are required and must be used during these classes. Students will turn them in to their teacher at course completion in order to receive credit and a passing grade.
- Important Note to Parents and Students: Independent courses require good study habits. Parents are able to check their student's progress anytime by logging on to their student's course online. **(Parent Initials)** _____ We recommend that a parent or guardian tracks their progress while taking this online class. Students should seek extra help from teachers as needed.
